Article 1

Introductory provisions

- (1) This Directive regulates the rules for awarding scholarships to international students in full-time degree programmes taught in English at Tomas Bata University in Zlín (hereinafter referred to as "TBU"), in accordance with the legal provisions set out in Act No. 111/1998 Coll., on Higher Education Institutions, as amended (hereinafter referred to as "the Act"), the TBU Scholarship Regulations and the internal regulations of TBU.
- (2) This Directive applies to international students (self-paying students) of TBU classified in IS/STAG category 6 in full-time Bachelor's, follow-up Master's and doctoral programmes taught in English at TBU.
- (3) Where the term "student" is used in this Directive, it shall be understood to include an applicant admitted to study at TBU within the meaning of this Article.

Article 2

Granting scholarships to international students – self-paying students

- (1) Scholarships for international students self-paying students at all levels of study are primarily awarded by the respective component part where the student concerned studies.
- (2) The amount of the scholarship is at the discretion of the relevant component part. However, it must be in accordance with the Act and the TBU Scholarship Regulations.
- (3) If funds are available, an extraordinary scholarship may also be awarded by the Rectorate. The Rector decides on the award of the scholarship and the conditions of the award are governed by the Scholarship Regulations in force.

Article 3

Final provisions

- (1) This Directive repeals and replaces Rector's Directive No. 35/2019, which came into effect on 16 December 2019, and Rector's Directive No. 14/2020, which came into effect on 1 August 2020.
- (2) The provisions of this Directive apply to students admitted to study in the 2025/26 academic year and onwards. Students already enrolled with a valid Scholarship Award Decision are subject to the provisions of the internal rules and regulations governing the award of scholarships from the fund intended to support internationalisation and international students in full-time degree programmes taught in the English language, in force and effect prior to the effective date of this Directive.
